1. Rental Agreement

1. Rental equipment is received in good condition and shall be returned in the same condition, ordinary wear excepted.
2. Customer agrees Epic Bouncers LLC may enter the premises at any time to recover rental equipment if necessary.
3. Customer agrees to reimburse Epic Bouncers LLC for attorney fees, court costs, and collection expenses incurred to enforce this agreement or collect amounts owed.
4. Customer shall not loan, sublease, relocate, alter, move, or transfer the equipment without written permission from Epic Bouncers LLC.
5. Customer agrees to pay the full rental amount and all charges for labor, delivery, cleaning, damage, repair, replacement, or loss of equipment when applicable.
6. Customer is responsible for repair or replacement costs for equipment damaged through negligence, misuse, theft, vandalism, fire, pets, sharp objects, unauthorized relocation, prohibited activities, or failure to follow operating instructions.
7. Customer is responsible for ensuring all users and users' guardians review and follow all posted and written safety rules.
8. Customer is responsible for providing a setup area free from animal waste, sharp objects, excessive slopes, standing water, underground hazards, and debris.

Weather Policy

Customer agrees to immediately discontinue use and evacuate all participants if winds exceed 15 MPH, lightning is present, thunder is heard, severe weather approaches, heavy rain creates unsafe conditions, or Epic Bouncers LLC instructs customer to stop use. Customer is responsible for monitoring weather conditions during the rental period.

Underground Utilities and Setup Area

Customer is responsible for identifying and marking any underground utilities, irrigation systems, sprinkler lines, septic systems, electrical lines, communication lines, water lines, or other hazards prior to installation. Epic Bouncers LLC is not responsible for damage to unmarked underground lines or devices.

Overnight Rentals

For overnight rentals, customer agrees to remove the blower from the inflatable and store it in a locked, secure location overnight. Customer is responsible for securing the inflatable, preventing unauthorized use, and protecting equipment from weather, theft, vandalism, misuse, and damage during the rental period.

Customer acknowledges that inflatable amusement devices involve known and unknown risks, including but not limited to slipping, falling, collisions, emotional injury, physical injury, paralysis, property damage, and death.

Customer voluntarily assumes all risks associated with use, operation, and possession of the rental equipment. Customer agrees to release, indemnify, defend, and hold harmless Epic Bouncers LLC, its owners, employees, contractors, representatives, and agents from all claims, actions, suits, proceedings, costs, expenses, damages, and liabilities, including reasonable attorney fees and costs, arising out of or connected to the delivery, setup, possession, use, operation, or return of the equipment.

Epic Bouncers LLC shall not be liable for injuries or damages resulting from inappropriate use, lack of supervision, unsafe behavior, weather conditions, acts of God, customer-supplied power sources, generator failure, electrical issues, or circumstances beyond the control or knowledge of Epic Bouncers LLC.

Water Slide Risks

Customer understands water slides present additional risks including slipping, falling, collisions, improper entry or exit, improper sliding techniques, and water-related injuries. Riders must slide feet-first only.

Generator and Electrical Disclaimer

Epic Bouncers LLC is not responsible for injury, damage, interruption of service, or equipment failure caused by customer-supplied generators, extension cords, electrical systems, outlets, or power sources.

Photo Release

Customer grants Epic Bouncers LLC permission to photograph rental equipment at the event location for advertising and promotional purposes, provided no identifying personal information is disclosed without permission.

3. Safety Rules & Operating Instructions

1. Adult supervision is required at all times. Children must never play on the inflatable without a responsible adult present.
2. No food, drinks, chewing gum, candy, shoes, glasses, jewelry, badges, pets, toys, sharp objects, face paint, glitter, colored streamers, party poppers, or silly string on or around the inflatable.
3. No climbing, hanging, or sitting on walls, netting, exterior surfaces, or equipment not intended for climbing.
4. No pushing, colliding, fighting, wrestling, flips, tumbling, roughhousing, or behavior likely to injure or distress others.
5. Do not allow anyone on the front safety step, near the blower, or on equipment while it is being inflated or deflated.
6. Do not overcrowd the inflatable. Riders should be grouped by similar age and size whenever possible.
7. Only one rider may descend a slide lane at a time. Dual-lane slides allow one rider per lane.
8. Water slides must be used feet-first only. No diving, head-first sliding, jumping from the top platform, or climbing outside designated areas.
9. If the blower stops working or power is lost, all riders must exit immediately and calmly. Check that the blower tube is secure and not obstructed. Inform Epic Bouncers LLC immediately if operation does not resume safely.
10. If high winds, lightning, thunder, heavy rain, or severe weather occurs, remove all participants immediately and disconnect power when safe to do so.
11. Customer agrees to remove any person violating posted or written rules.

Safety/How-To Checklist

- ☐ I have been shown how the inflatable is secured.
- ☐ I have been shown how to turn the blower on/off.
- ☐ I have been instructed how to safely disconnect power in an emergency.
- ☐ I understand all participants must exit immediately if winds exceed 15 MPH or severe weather is present.
- ☐ I understand all riders must use slides feet-first only.
- ☐ I understand no horseplay, flips, wrestling, or unsafe activities are allowed.
- ☐ I understand no shoes, sharp objects, food, drinks, gum, eyeglasses, or jewelry are allowed on the inflatable.
- ☐ I understand adults 18 years old and up must always be present to supervise.
- ☐ I have received written and verbal instructions for safe operation and agree to follow all safety rules.
